With reference to the captioned subject, it may please be noted that the submission of Corporate Governance Report under Regulation 27(2) of SEBI Listing Regulations is not applicable to B J Duplex Boards Limited (“the Company”).

The Company is claiming exemption under Regulation 15(2) of SEBI Listing Regulations, as Corporate Governance provisions are not applicable to a listed entity, whose paid-up equity share capital & Net Worth doesn't exceed an amount of Rs. 10 Crores and Rs. 25 Crores respectively as on the last day of the previous financial year.

It may please be noted that as on March 31, 2025, the Paid-up Equity Share Capital & Net Worth of the Company stood at Rs. 49.29 Lakhs and a deficit of Rs. 174.80 Lakhs respectively. Therefore, the Company is exempted under Regulation 27(2) read with Regulation 15(2) of SEBI Listing Regulations and is not required to submit Corporate Governance Report for the quarter ended on September 30, 2025.

Also, the Company undertakes that whenever these regulations will become applicable to the Company in near future, it will ensure compliance with the said requirements of the above regulations within six months from the date on which these provisions become applicable to the company.
