- These financial results have been prepared in accordance with the recognition and measurement principles of Indian Accounting Standards ("Ind AS") prescribed under Section 133 of the Companies Act, 2013 read with the relevant rules issued thereunder and the other accounting principles generally accepted in India and in accordance with the circulars, guidelines and directions issued by the Reserve Bank of India ("RBI") from time to time.
- The Company is engaged primarily in NBFC business. The operations of the Company fall under "financing activities" which is considered to be the only reportable segment in accordance with the provisions of Ind AS 108, "Operating Segments". The Company operates in a single geographical segment, i.e., "domestic".
- The figures for the quarter ended March 31, 2025 are the balancing figures between audited figures in respect of the full financial year and published year-to-date unaudited figures up to the end of the third quarter of the respective financial year, which were subject to limited review by the statutory auditors.
- Figures for the previous quarters/periods have been regrouped/reclassified, wherever necessary, to correspond with the current period's classification/disclosures. There may be minor rounding-off variances as figures are converted into lakhs.
- The Company has pledged certain of its investment securities with a large financial institution to avail a Loan Against Securities facility. The aggregate carrying value of the pledged securities was ₹2,305.60 lakhs as on June 30, 2025.
- The Company successfully concluded its Rights Issue, a strategic initiative to augment its capital base. The Rights Issue, which opened on June 20, 2025, and closed on July 4, 2025, involved the issuance of 70,05,573 fully paid-up equity shares at a price of ₹70 per share (including a premium of ₹60 per share), resulting in a capital infusion of ₹4,903.91 lakhs. The issue garnered overwhelming participation from investors and was oversubscribed by more than 123%. The process of allotment and credit of Rights Equity Shares to the demat accounts of the respective investors has been completed successfully. BSE Limited has granted approval for the listing and trading of the Rights Equity Shares from July 21, 2025.
